Steve Jellen's Address to the Board

Distinguished officials, ladies and gentlemen, my name is Steve Jellen. I am secretary of the Madison League, a public interest group dedicated to Madison County. We think that the public would welcome more oversight by the county board. Public criticism relating to the Bathon case is largely that someone should have known. We'll never know if better oversight might have saved troubled taxpayers from compounding misery and whether it might have prevented Fred Bathon, who was an otherwise good treasurer, from ruining his life and hurting the county's reputation. State law clearly gives the county board a duty to oversee the treasurer. While the treasurer is sovereign of his statutory duties, he nonetheless reports to and settles his accounts with the county board, which has the power to question him under oath. Obviously the law intends oversight. Expert investment advice might set everyone's mind at ease about investment returns. We think that the treasurer is likely right about short term interest rates, but that brings us to question long term investments. We think that before the county ties up large sums of money long term, the county board should first consider why the county would hold money for which it has no foreseeable need. However, we think too that the county should hold ample reserves. They help lower costs and provide for "rainy days." But we suggest that the board consider adding something like a 180 days maximum limit to the current 120 days minimum for reserves. Present reserves are nearly equal to a year's operating expenses. Much of the present surplus has apparently come from fees in excess of costs. Taxes have been mostly in line with expenditures. That implies to us that some fees are too high. But it could also mean that some departmental budgets have been cut too much and that needed repairs and or improvements have been deferred too long. There are many capital projects that would be good investments of the surplus funds that exist now. We hope that policy can be developed which provides consistency over time and across elections, which reduces political tensions and which keeps revenue collections and investments appropriate manifest needs.

Jack Dougherty's Address to the Board

Unlike Mr. Jellen, I did not write anything down. My name is Jack Dougherty, I am a lifelong resident of Madison County, I am a tax payer, citizen, voter, I am a member of the Madison League along with Mr. Jellen and I have also been practicing law for 20 years in Madison County. I want to expand a little bit on what Mr. Jellen talked about, starting with the notion of oversight. Specifically the idea of an oversight committee that has been brought up. Because I am interested in this topic and I am interested in local and good government generally, I decided to go dig into the statute book and see what is out there. What I have discovered is; creating an oversight committee is neither prohibited nor specifically required by any statute. The statutes have been interpreted by almost no courts. So this is wide open for the county board to do as they see best in this situation. If anything I have learned in the last 10 years, watching local government, it affirms the idiom given to us by Ben Franklin that an ounce of prevention is worth a pound of cure. An ounce of prevention 10 years ago with an oversight committee might have prevented a lot of problems and headaches and misery that we now suffer. My summary is that this is legally permissible and probably a good idea in the spirit of good government. The other issue and the reason we need an expert investment advice is we are talking about a huge amount of money, 140 million dollars. I haven't had many years where I have made that kind of money. That amount of money is probably hard to justify, as I look at our accumulation of funds it is possible in the future if we continue to accumulate funds at the rate we are we might have an access of accumulation of funds and tax objectors might be able to levy objections which would interfere with our ability to levy taxes. Finally, the 300 days that we have, seems to be excessive. If our policy is between 120 and 180 days, I think that any funds we have that are not unrestricted funds really

belong in the local economy. If we have the money to put people to work then we should put people to work. We have cut our local government to the bone, our services have suffered. I think it is time to recall the people we have laid off.

(B) Definitions

LAWN CARE SERVICE. A business primarily engaged in providing landscape care and maintenance services for lawns, trees, shrubs, plants or gardens on private or public property. Services include lawn maintenance, tree trimming, tree removal, hedge trimming, hedge removal, stump removal and chipping service. This use also includes snow removal services. Retail and wholesale sales of products and services are not permitted.

§ 93.023 "A" AGRICULTURAL DISTRICT

- (**D**) "A" Special Uses. (See § 93.152, §93.168
 - (1) [Reserved] Lawn Care Service in compliance with §93.103.

§93.103 Lawn Care Service

(A) Use Restrictions.

A lawn care service operation shall only be permitted as special use permit within (A) Agriculture Districts in accordance with the following restrictions:

- 1. All equipment stored shall be related to the permit holder's primary business or personal use.
- 2. <u>No customers shall be permitted on-site.</u>
- 3. No employees shall be permitted on-site except to pick-up or drop-off equipment.
- 4. <u>No equipment may be operated on-site</u>. Equipment may be tested on-site so long as the activity takes place within an enclosed structure. This includes lawn mowers, wood chipping machines, chainsaws and similar equipment.
- 5. <u>Hours of Operation: Monday through Friday 6 AM to 9 PM, Saturday and Sunday 7 AM to 7 PM.</u>

(B) Minimum Tract Size.

The minimum tract size shall be four (4) acres on one or more contiguous parcels under the same ownership.

(C) **Buffer Yard and Screening**

All lawn care service uses shall be a minimum of 25 feet from any single family residential property line. All equipment and materials shall be stored within an enclosed structure.

(D) Lighting

- 1. No lighting shall be directed onto an adjacent property.
- 2. All area lighting shall be shielded so as to limit the amount of light shed onto an adjacent property.

(E) Signs

No signs shall be permitted.

Mr. Jackson stated that the Planning and Development Department has presented a text amendment to the Madison County Zoning Ordinance that would add lawn care service as a listed special use permit within the Agriculture District. Jackson stated that this amendment was at the request of Andrew Carruthers, attorney for Corey Murphy, a Madison County Resident who would seek the special use permit if the text amendment is approved. Jackson stated that the text amendment defines the lawn care service use and supplementary requirements, including lighting, buffers, minimum lot size, and hours of operation; IV. A letter of opposition was submitted to the Zoning Board of Appeals by William and Joyce Sunderland, property owners of 3889 Alliance Drive, Bethalto, Illinois, stating concerns with impacts a commercial operation would have on the Agriculture District; V. A letter of opposition was submitted to the Zoning Board of Appeals by Chris Cassidy, property owner of 4119 Fosterburg Road, Alton, IL, stating concerns with the impacts the text amendment would have on the Comprehensive Plan; VI. Joyce Suderland, property owner of 3889 Alliance Drive, Bethalto, Illinois, stated opposition to the request due to negative impacts on adjoining property owners. Ms. Sunderland stated that she is the adjacent property owner of Corey Murphy, property owner of 3919 Hodge Lane, who is currently operating a tree trimming business. Ms. Suderland stated that noise emitted from trucks and chainsaws has a detrimental impact on her property. Ms. Suderland stated that she did her diligence prior to purchasing her home, and that she has an expectation that the County land use regulations would protect her investment; VII. 
